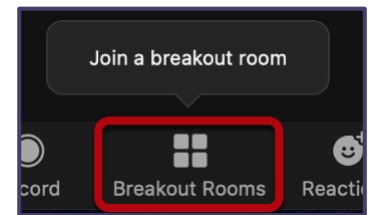

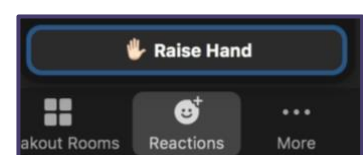

THE POLITICS OF CRISIS

Since the beginning of 2020, COVID-19 has been profoundly affecting our everyday life raising numerous questions on the social and political implications of the pandemic, and the political responses to this public health crisis. Despite the singularity of the current crisis, it also connects to broader questions in relation to ongoing political, social, economic, financial, and environmental transformations. More specifically, it raises a number of questions around the politics of crisis: what are the impacts of crises like the COVID-19 on the public opinion? What are political actors' strategies from the local to the transnational level? How do crises affect public policy and multilevel governance arrangements? What are the implications of framing a situation as a crisis? How do countries and national institutions and political actors react to these disruptions? How have these changes affected political processes and outputs? What may explain divergences or similarities in these reactions? Is it possible to distinguish between short term reactions to an urgent situation, and more long-term impact on the functioning of public policy and politics in general? These questions will be addressed during the plenary session which will be composed of a keynote speech followed by a roundtable.

The **keynote speech** will be held by **Giliberto Capano**, Professor of public policy at the University of Bologna, specialist in public administration and public policy in comparative perspective. Based on his recent work on the political reactions to COVID-19 in Italy and abroad, he will specifically focus on the political impact of COVID-19. His keynote speech will be entitled:

Understanding systemic crises. Conceptual and theoretical challenges for political science in the aftermath of the COVID-19 pandemic.

The **roundtable** will gather **Rahel Kunz**, Senior Lecturer in international relations at the University of Lausanne, **Géraldine Pflieger**, Associate Professor of urban and environmental policy at the University of Geneva, and **Elisabeth Prügl**, Professor in political science at the Graduate Institute Geneva, to further discuss the politics of crisis. Bringing together researchers working on different policy areas facing a situation of crisis (finance, climate change and migrations), the roundtable intends to propose complementary insights around two sets of questions. First, speakers will reflect on the 'crisis', its mechanisms (causes and origins, concrete manifestations, etc.) but also the way it is understood and framed as a crisis (what it means to define an issue in crisis, what is considered as being 'in crisis', etc.). Secondly, speakers will discuss the consequences of the 'crisis', both in terms of (non)transformations within our society and regarding the policy area concerned by the crisis. For instance, what are the consequences of framing and managing an issue as a crisis? How are the practices of that field transformed by major disruptions? Taken together, the different interventions will help address a final question relating to the similarities and differences between policy areas. Each speaker may select the questions they want to address or choose more specific questions depending on their own research area and field of expertise.

The Young Scholar's Forum of the Swiss Political Science Association is a platform where we address topics and issues that are of particular relevance to PhD students and postdoctoral researchers.

In previous years, the Forum focused on issues closely related to young scholars' career prospects such as making one's research visible for non-academic audiences or getting published. In 2021, we addressed questions pertaining to mental health, work-life-balance and self-care that are just as important as climbing the academic ladder. This year, we would like to draw attention to the question of which career path to take after completion of a PhD in political science.

What's next? Career prospects outside academia

This event on possible non-academic career paths available to people with a PhD in political science is targeted at (advanced) **PhD students and post-Doctoral researchers**.

Not only because of the impact of the COVID-19 pandemic on scientific careers but also because of the precarious working conditions within academia, a growing number of PhD students and early-career researchers are looking into careers outside of academia. Thousands of jobs in the university sector could be lost over the next couple of years and in July 2020, Nature reported of a seismic readjustment in scientific careers.

Despite these developments, PhD holders remain highly employable and our aim is to offer information about interesting alternatives to academic pathways and provide practical tips on how to find non-academic jobs. To this purpose we have a panel with three *alumni* who successfully transitioned into the non-academic market and a career consultant specializing in accompanying this transition. They will share their personal and professional experiences and give us some insights into how to exit academia. Young scholars will also have the opportunity to ask questions
