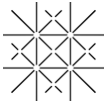

Public transportation

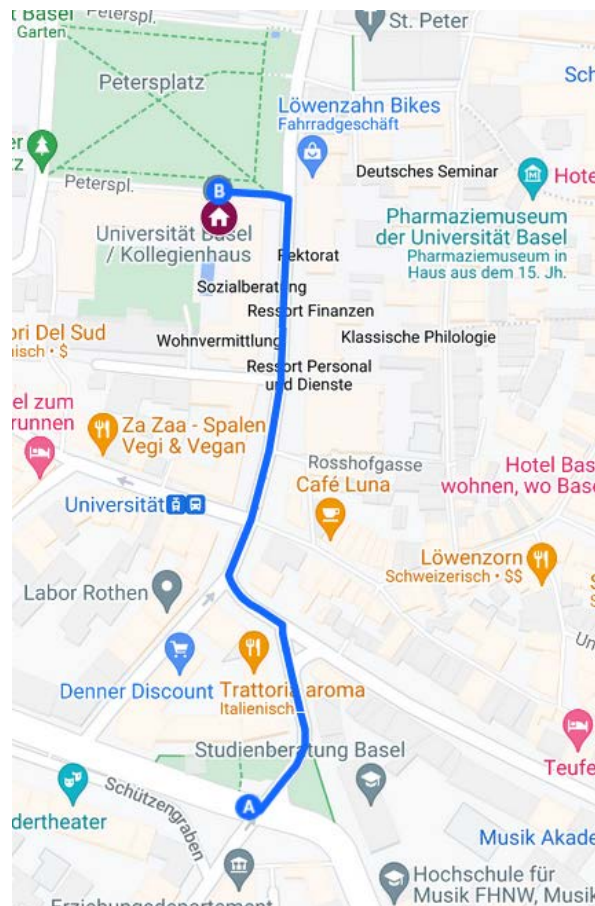
