## SPSA Young Scholar Award

Every other year, the SPSA awards two prizes for young researchers: one for the best political science journal article and one for the best dissertation. Both prizes are endowed with CHF 1500.

The prize for young researchers (journal article or dissertation) can be awarded to a candidate who is a member of the SPSA and who works at a Swiss research institution or holds a Swiss university degree. The candidate is less than 35 years old (at the opening of the competition) or has defended their doctoral thesis less than two years before the opening of the competition.

The prize for the best journal article will be awarded to a single-authored article published between 1 February 2022 and 31 January 2024 in a peer-reviewed scientific journal.

The prize for the best dissertation is awarded to a dissertation defended between 1 February 2022 and 31 January 2024. The candidacy must include the jury's report. You can only apply for one of the two prizes; simultaneous candidacy for both prizes is not permitted. Candidates are selected by three external experts from different fields of politicalscience. If necessary, the Executive Board will make a pre-selection. There is no right of appeal for the candidates.

## Awards

### **Universität St. Gallen (HSG) / School of Economics and Political Science / Department of Political Science**

#### *Financial Times Responsible Business Education Award*

Anna Stünzi (University of St.Gallen), together with Malte Toetzke and Florian Egli (both ETH Zurich) received this year's Best Academic Research with Societal Impact award by the Financial Times. They developed a natural language processing model — called ClimateFinanceBERT — that identifies and categorises these climate projects. Countries self-report the climate projects and the money they contribute, all using different methods and in a process that is not transparent.

## *2023 Palmer Prize*

Christoph Steiner (University of St.Gallen) received the award for the best paper published in the journal of the Peace Science Society. The paper reveals that political imprisonment lengths in China are influenced by perceived threat and ethnicity, with ethnic minorities facing longer sentences. Steinert's work contributes significantly to understanding China's political imprisonment, addressing its prevalence and opacity.

Die Akademien der Wissenschaften Schweiz haben erstmals den «[National Open Research Data Prize](#)» vergeben. Swissvotes, die von Année Politique Suisse am Institut für Politikwissenschaft (IPW) der Universität Bern betriebene Datenbank zu den eidgenössischen Volksabstimmungen ([www.swissvotes.ch](http://www.swissvotes.ch)), erreichte unter 36 eingereichten Projekten aus allen Wissenschaftsdisziplinen den 2. Platz («Silver-Award», dotiert mit CHF 7'000). Speziell positiv hervorgehoben wurden von der Jury die freie Zugänglichkeit der Swissvotes-Daten sowie ihre breite Nutzung, die über die Grenzen der Politikwissenschaft, aber auch der Wissenschaft überhaupt hinaus reicht.

*16. Aarauer Demokratietage «Föderalismus und Demokratie»: 14.+15. März 2024, Kultur- und Kongresshaus Aarau*

Der Föderalismus ist – zusammen mit der direkten Demokratie – eine der tragenden Säulen des schweizerischen Bundesstaates. Das föderale System ermöglicht den einzelnen Ebenen ein grosses Mass an Gestaltungsmöglichkeiten. Aber es gibt auch Kritik am Föderalismus: Er sei zu teuer und zu kompliziert oder verhindere notwendige Reformen. Was ist an diesen Vorwürfen dran? Die Aarauer Demokratietage greifen aktuelle Fragen zum Verhältnis von Demokratie und Föderalismus auf und geben der interessierten Öffentlichkeit die Möglichkeit, diese mit Expert:innen zu diskutieren.

### **DeFacto**

*«Polit-Forum und DeFacto live in Bern»: Neues Parlament, neue Regierung – die Herausforderungen 2024*

Die Konkordanz gilt als zentrales Element der Konsensdemokratie und des politischen Systems der Schweiz. Im Gegensatz zur Mehrheitsdemokratie sollen möglichst viele Interessen in einen politischen Entscheid eingebunden werden. Dadurch sollen einvernehmliche Lösungen gefunden werden, die von allen wichtigen Kräften und Interessensgruppen mitgetragen werden.

Doch in den letzten Jahren wurde es zunehmend schwieriger, breit akzeptierte Lösungen zu finden. Polarisierung, Personalisierung und Mediatisierung haben auch in der

Schweizer Politik ihre Spuren hinterlassen.

Wie können das neu gewählte Parlament und die neue Regierung unter diesen Umständen tragfähige Lösungen finden? Wie kommen stabile Mehrheiten zu Stande oder ist dies gar nicht mehr erwünscht? Welche Themen muss das Parlament ab 2024 vordringlich anpacken? Hat das Schweizer Konkordanzsystem überhaupt noch eine Zukunft?

#### *Debating Human Rights*

In this FNS Spark Project Simon Hug (Université de Genève), Léa Meyer (Université de Genève), and Christoph Steinert (University of St.Gallen) examine debates in the UN Human Rights Council in comparison with its predecessor organization, the UN Commission on Human Rights, which was replaced by the UN Human Rights Council in 2006. They focus on the measurement of emotions in human rights debates based on new algorithms that use video data to measure emotions.

### **Universität Bern, Année Politique Suisse (APS)**

Année Politique Suisse verfasst neben der Chronik ([www.anneepolitique.swiss](http://www.anneepolitique.swiss)) seit einigen Jahren Jahresrückblicke zu den wichtigsten politischen Ereignissen in der Schweiz. Im Jahresrückblick 2023, der Ende Dezember letzten Jahres erschienen ist, werden drei Perspektiven eingenommen: Aus einer Medienlogik dominierten 2023 die eidgenössischen Wahlen, aus einer Vorstosslogik Gleichstellungs- und Asylfragen und aus einer Geschäftslogik das Bundesgesetz über eine sichere Stromversorgung mit erneuerbaren Energien. Im ausführlichen Jahresrückblick finden sich zahlreiche weitere wichtige Ereignisse in 23 unterschiedlichen Themenfelder. Er kann [hier](#) heruntergeladen werden.

### **Zentrum für Demokratie Aarau (ZDA)**

*Digitale Partizipation – es braucht die Zusammenarbeit der Kantone*

Der DigiPart-Index erfasst auf einer Skala von 0 bis 100, inwiefern es in den Kantonen der Schweiz möglich ist, sich digital an politischen Prozessen zu beteiligen. Im dritten Jahr seiner Erhebung bleibt der Durchschnittswert über alle Kantone hinweg relativ tief. Zum dritten Mal in Folge unterscheiden sich Spitzenkanton und Schlusslicht um Faktor zehn. Während sich in den Kantonen in der Schlussgruppe in den vergangenen drei Jahren in Sachen digitale Teilhabe nur wenig getan hat, kam es in der Spitzengruppe dieses Jahr zu einer weiteren Steigerung. Das liegt unter anderem an der Wiedereinführung von e-Voting.
